20/46 County Business Review

An abstract of proposals for constitutional revisions was presented for discussion. Rules revision effective 17 December 2020 to be ratified by ACM were approved and agreed as follows:

- Section 2 Name; new clause 2.3: "The status of the Association is an unincorporated association operating as a voluntary body to achieve the aims as determined in this Constitution and on behalf of its members."
- ii Section 3 Affiliation and Composition; amend clause 3.1.3: ".... such other bodies as the Association may determine from time to time in accordance with local needs and interests."
- iii Section 3 Affiliation and Composition; new clause 3.2.2: "A club, league or associated organisation affiliating to Swim England via the Association shall in the first instance submit an application for membership to the Association; whereby

3.2.2.1 the Association will review the constitution of said organisation and any other evidence required in accordance with the procedures of the Region and as specified by the Association; and 3.2.2.2 on acceptance of and agreement by the Association, the application shall be forwarded to the Region by the Association for consideration against the national criteria approved by Swim England."

- iv Section 3 Affiliation and Composition; renumber/amend clause 3.2.3: "The Association reserves the right to recommend to the Region that a request for affiliation of an organisation or individual not deemed to be in the best interests of the Association, its' membership, and the aquatic disciplines under its' jurisdiction as defined in these Rules is declined."
- v Section 8 The Council; Sub-section 8.3 Powers; amend clause 8.3.6.1: "..... authorise the Executive to

establish and implement policy and procedure (hereinafter "By-Laws") and repeal and amend such By-Laws as from time to time may be considered necessary in the best interests of the Association to regulate the routine business of the Association; and "

- vi Section 8 The Council; Sub-section 8.5 The Annual General Meeting; amend clause 8.5.1: "The ACM shall be held in June at a venue, date and time as the Executive shall determine whereby members and constituent Clubs shall be given 28 days' notice of said meeting; and"
- vii Section 8 The Council; Sub-section 8.5 The Annual General Meeting; amend clause 8.5.1.6: "..... shall be distributed not less than fourteen days prior to the date of that meeting."
- viii Section 8 The Council; Sub-section 8.5 The Annual General Meeting; amend clause 8.5.2.5: "to elect a Life President, a Life Member, or other Honorary Members;"
- ix Section 8 The Council; Sub-section 8.5 The Annual General Meeting; new clause 8.5.2.7: "To set and approve the annual affiliation fee."
- x Section 8 The Council; Sub-section 8.6 Special Council Meeting; amend clause 8.6.1: "The Council may call an SCM on its own initiative by a simple majority or"
- xi Section 8 The Council; Sub-section 8.10 Motions; amend clause 8.10.5.3: "A motion for consideration that embodies a proposal to effect a change to the Constitutional Rules of the Association shall: be referred to the Association Rules Committee for consideration prior to the ACM or SCM;"
- xii Section 8 The Council; Sub-section 8.11 Voting; amend clause 8.11.3: "Voting on all motions or amendments of motions that do not embody a proposal to effect a change to the Constitutional Rules of the Association shall be by a show of hands unless the Chairman directs otherwise, whereby a simple majority of those present and eligible to vote shall pass said resolution."
- xiii Section 8 The Council; Sub-section 8.11 Voting; new clause 8.11.4: "Voting on all motions or amendments of motions that embody a proposal to effect a change to the Constitutional Rules of the Association shall be by a show of hands unless the Chairman directs otherwise, whereby a majority of two-thirds of those present and eligible to vote shall pass said resolution."
- xiv Section 9 The Executive; Sub-section 9.1 Composition; amend clause 9.1.1.4: "The Executive shall comprise the following Life Presidents, Life Members, and other Honorary Members;"
- xv Section 10 Finance; Sub-section 10.1 Accounting; amend clause 10.1.7: "The income and property of the Association shall be applied only in the furtherance of the aims and objectives of the Association and no part thereof shall be paid by way of bonus, dividend, donation or profit to any member of the Association, constituent Club, or other individual or external agency or organisation save as purposes specified in clause 9.3.6 of these Rules."
- Section 10 Finance; Sub-section 10.5 Property; new clause 10.5.2: "A Custodian shall be an officer or other postholder of the Association unless otherwise agreed by the Executive Officers; whereby 10.5.2.1 the responsibility as a Custodian of the Association shall be determined by resolution of the Executive Officers; and

10.5.2.2 whose responsibility as a Custodian of the Association shall be determined by resolution of the Executive Officers and whose responsibility shall cease on resignation from that role or until removed from that role by resolution at a Meeting of the Executive."

- xvii Section 10 Finance; Sub-section 10.5 Property; renumber/amend 10.5.3: "The names of Custodians, the number of which shall be determined by the Executive Officers as deemed necessary, shall be reported annually to a Meeting of the Council and entry in the minutes of that meeting shall be conclusive evidence of such appointment."
- xviii Annex A; Section A1 Election of Officers; amend clause A1.1.2.3: "Life Members;"
- xix Annex A; Section A1.4 Appointments; amend clause: "The Council shall appoint a Child Protection Officer (Welfare Officer) at the ACM, who must not be less than 18 years of age, who should have an appropriate background and who is required to undertake appropriate training in accordance with Wavepower."
- xx Annex A; Section A2 Elected Committees; amend clause A2.1.1: "Each Committee shall normally meet at least twice a year. Meetings may be held by electronic conferencing at the discretion of the Committee."
- xxi Section 1 Definitions; new clause 1.1.8: "General Meeting" shall mean an Annual Council Meeting or a Special Council Meeting.
- xxii Constitution to be revised throughout with "Annual General Meeting" and abbreviation "AGM" to read "Annual Council Meeting" and "ACM".
