- ii Section 3 Affiliation and Composition; new clause 3.2.1.7: Individuals awarded honorary Life Membership in recognition of long service at County level and who are no longer a member of an affiliated club.
- iii Section 11 Finance; Sub-section 11.1 Accounting; amend clause 11.1.7: The income and property of the Association shall be applied only in the furtherance of the aims and objectives of the Association and no part thereof shall be:

11.1.7.1 Paid by way of bonus, dividend, donation, or profit to any member of the Association, constituent Club, or other individual or external agency or organisation save as for purposes specified in clause 9.3.6 of these Rules; or

11.1.7.2 devolved to individuals, sub-committees or an external agency or organisation; or 11.1.7.3 used for the purpose of underwriting activities or events that are the responsibility of an external agency or organisation; and noting

11.1.7.4 that the aforementioned stipulations apply regardless of affiliation.
