Agreed to incorporate 25/over age group for those events; to be accepted at DCASA discretion. Referred to STC to progress. 2021 Swim England Open Water Festival cancelled.
- SWR WP meeting minutes 5 July 2021 inaccurate in regard to DCASA business; apology received. Constitutional rules within which DCASA obliged to operate in the decision-making process formally submitted to SWR WP Cmt with hope expressed that our county rules be respected in future partnership and collaboration; SWR Chair copied in. Matter closed.
- 2. Expression of interest from Lyme Regis WP in regard to a satellite club. Options outlined; DCASA WP Secretary in contact with Lyme Regis organiser. Pre-AGM query received in regard to protocol if there are no nominations for all Executive Officer posts; can one Executive Officer undertake two Executive roles? Response from SE insurers Howden as follows: "From the point of view of liability all roles within a club set up will be covered so long as the individual has the relevant background and training to fulfil that role. Also, one individual can do two
